# AMENDMENT OF THE BYLAWS OF FAIRWINDS OF ANNAPOLIS CONDOMINIUM

EXPLANATORY STATEMENT: On or about October 23, 1978, the original bylaws of the Council of Unit Owners of Fairwinds of Annapolis Condominium were recorded among the Land Records of Anna Arundel County, Maryland at Liber WGL 3136, folio 656. The Council of Unit Owners of Fairwinds of Annapolis Condominium, by the affirmative vote of at least 75 percent of the votes of said Council of Unit Owners and of at least 75 percent of the percentage interests of the common element ownership of said condominium, hereby amends its said Bylaws as hereinafter provided.

NOW, THEREFORE, on this 19<sup>th</sup> day of February, 1981, Section 6 of Article XIII of the above-described Bylaws of the Council of Unit Owners of Fairwinds of Annapolis Condominium is hereby amended by deleting the existing provisions of said section in full and by inserting, in lieu thereof, the following language:

Section 6. Amendments to Bylaws. Except as elsewhere herein or in the Declaration provided otherwise, these Bylaws may be modified or amended by the affirmative vote of that percentage required by the Maryland Horizontal Property Act of all unit owners at a meeting of the Association duly held for such purpose. The foregoing amendment shall take effect immediately.

#### SECOND AMENDMENT OF THE BYLAWS OF

#### FAIRWINDS OF ANNAPOLIS CONDOMINIUM

EXPLANATORY STATEMENT: On or about October 23, 1978, the original Bylaws of Fairwinds of Annapolis Condominium were recorded among the Land Records of Anna Arundel County, Maryland at Liber WGL 3136, folio 656. These Bylaws were subsequently amended in accordance with a certain Amendment of the Bylaws of Fairwinds of Annapolis Condominium recorded on or about March 31, 1981 among said Land Records at Liber WGL 3394, folio 862. The Council of Unit Owners of Fairwinds of Annapolis Condominium, by the affirmative vote of Unit owners having sixty-six and two-thirds percent (66 2/3%) or more of the votes of said Council of Unit Owners and by the affirmative vote of Unit owners owning sixty-six and two-thirds percent (662/3%) or more of the percentage interests of the common element ownership of said condominium, hereby amends its said Bylaws as hereinafter provided.

NOW, THEREFORE, as of the 28<sup>th</sup> day of January, 1982, the said Bylaws of Fairwinds of Annapolis Condominium are amended as follows:

**A.** Section I of Article III of the above-described Bylaws of Fairwind of Annapolis Condominium is hereby amended by deleting the existing provisions of said section in full and by inserting, in lieu thereof, the following language:

**Section I:** Number and Qualification. The affairs of the Association shall be governed by a Board of Directors acting on behalf of the Association. The Board of Directors shall be composed of seven (7) members, all of whom shall be elected by written secret ballot by the Unit owners.

**B.** Section 4 of Article III of the above-described Bylaws of Fairwinds of Annapolis Condominium is hereby amended by deleting the existing provisions of said section in full and by inserting, in lieu thereof, the following language:

Section 4: Election and Term of Office. The term of office of each Director shall be two (2) years; provided, however, that each director shall hold office until the next meeting of the Board of Directors following the election of his successor; provided further that, if and whenever the number of directors on the Board of Directors shall be increased, the initial term of office for a sufficient number of newly created directorships shall be limited to a period of one (1) year so that, at the annual election by the Association next occurring thereafter, elections shall occur for directors comprising at least one-half of the Board of Directors. Whenever any election of directors occurs where directors are elected for terms of different length, the persons receiving the greater number of votes shall be elected to the directorships having the longer term of office.

The foregoing amendments shall take effect immediately.

# THIRD AMENDMENT OF THE BYLAWS OF FAIRWINDS OF ANNAPOLIS CONDOMINIUM

EXPLANATORY STATEMENT: On or about October 23, 1978, the original Bylaws of Fairwinds of Annapolis Condominium were recorded among the Land Records of Anna Arundel County, Maryland at Liber WGL 3136, folio 656. These Bylaws were subsequently amended in accordance with a certain Amendment of the Bylaws of Fairwinds of Annapolis Condominium recorded on or about March 31, 1981 among said Land Records at Liber WGL 3394, folio 862 and by a certain Second Amendment of the Bylaws of Fairwinds of Annapolis Condominium recorded on or about February 18, 1982 among said Land Records at Liber WGL 3472, folio 757. The Council of Unit Owners of Fairwinds of Annapolis Condominium, by the affirmative vote of unit owners having sixty-six and two-thirds percent (66 2/3%) or more of the votes of said Council of Unit Owners and by the affirmative vote of Unit owners owning sixty-six and two-thirds percent (66 2/3%) or more of the percentage interests of the common element ownership of said condominium, now hereby further amends its said Bylaws as hereinafter provided.

NOW, THEREFORE, as of the 16<sup>th</sup> day of February, 1984, Subsection (j) of Section 2 of Article III of the above-described Bylaws of Fairwinds of Annapolis Condominium is hereby amended by deleting the existing provisions of said subsection in full and by inserting, in lieu thereof, the following language:

(j) Enforcing obligations of Unit owners, allocating common profits and common expenses, if any, and doing anything and everything else necessary and proper for the sound management of the property. In this connection, the Board of Directors shall have the power to levy fines against unit owners for violations of the rules and regulations. A fine of Five Dollars (\$5.00) may be levied for the first violation of any rule or regulation; a fine of Ten Dollars (\$10.00) may be levied for the second violation of the same rule or violations of the same rule or regulation. Each day a violation continues, after notice, shall be considered a separate violation. Collection of fines may be enforced against the Unit owner or Unit owners involved as if the fines are a common charge owed by the particular Unit owner or Unit owners. Where a Unit owner persists in violating the Rules and Regulations, the Board of Directors may require him to post a bond, satisfactory to it, to secure future compliance with the Rules and Regulations.

The foregoing amendments shall take effect immediately.
